## **APPLICATION FOR VENDORS/EXHIBITOR**

The following terms and conditions shall apply violation of any of these terms shall cancel this permit.

1. This permit does not allow subletting of space nor is it transferable.
2. The vendor/exhibitor accepts full responsibility for all liabilities for damages to person or property arising out of his/her use and occupancy of these premises.
3. The Lafayette County Fair will not be responsible for any loss by theft, fire, accident, or act of God.
4. The cost of inspection fees and special phone fees are to be borne by the vendor/exhibitor.
5. Posting of self-adhering stickers will not be allowed to fair ground property, either permanent or temporary, or to a vehicle upon the fair grounds.
6. The applicant shall not interfere with other vendor/exhibitor by activity beyond the space rented or by nuisances such as excessive volume on a public address system, musical instruments, ECT.
7. The Lafayette County Fair has given Wenzels (Carnival) the exclusive on Funnel Cake's, Corn Dog's, Lemonade, and Popcorn Wagon. No other vendor/exhibitor may sell these items. No for profit vendor shall undersell Wenzels (Carnival) stands.
8. Vendors/exhibitor at the Lafayette County Fair shall not sell, or allow to be sold any sharp instrument, which includes but not limited to throwing stars, knives, chains, ECT. Or any firearms of any description, smoke bomb, stink bombs or anything with fuses, and dangerous weapons or explosives.
9. Commercial building and outside vendors area hours 4:00 to 10:00 p.m. Wednesday, 10:00 a.m. to 10:00 p.m. Thursday and Saturday, 10:00 a.m. to 10:30 p.m. Friday, and 10:00 a.m. to 4:00 p.m. on Sunday. Commercial building vendors may start to be torn down at 4:00 p.m. on Sunday. In fairness to all vendors/exhibitor and the public, we ask that all vendors/exhibitor be staffed during the hours previously stated. Outside vendors/exhibitor may remain open and staffed until the midway closed. Food concessions may remain open each night until it is no longer profitable. If you are applying for a food concession, you will need to meet the State Department of Health or Agriculture standards.
10. Outside and commercial building vendors/exhibitor may set up on Monday or Tuesday. Food concessions should be set up and ready to be state inspection by 2:00 p.m. Tuesday. All vendors must be set up and ready to open by 4:00 p.m. on Wednesday. Rental fee shall including access to camping and electricity.
11. The applicant agrees to defend, indemnify, and hold harmless the Lafayette County Fair, its Board of Directors and employees from any and all claims brought by anyone arising from the Lafayette County Fair, including but not limited to, claims arising out of construction, operations, maintenance, supervision, inspection or use of any buildings or grounds at the Lafayette County Fairgrounds.
12. Each Vendor/exhibitor shall obtain and keep in force until completion of the "project" including set up and tear down, a commercial general liability insurance contract with liability limits equal to or greater than \$1,000,000./each occurrence. The vendor will provide a certificate of insurance to Lafayette County Fair at the beginning of the Fair. Such vendors/exhibitor shall name Lafayette County as an Additional Insured.



*Hold harmless/indemnification:* Vendors/exhibitor shall be solely responsible for any and all injuries to persons or damages of property or any other injury claim, damage or loss of whatever nature, arising directly or indirectly from the "project." Vendors shall INDEMNIFY, SAVE AND HOLD HARMLESS Lafayette County Fair and its employees, Lafayette County Fair Board, Board of Directors of Lafayette County, and volunteers from and against all liability, loss, damages, claims, costs and expense (including attorney fees) arising out of injury to person or damages to property or any other injury, claims, damage, loss, cost or expense arising from the "project."

13. The Lafayette County Fair Board reserves the right to cancel or deny any application by refunding the deposit and indicating the reason for cancellation or denial. There will be no refunds of deposits for cancellation by the vendor/exhibitor.
